Spokane Valley has not performed any independent analysis as to the existence or non-existence of water capacity, and specifically makes no representations as to the accuracy of the water capacity information provided by any water purveyor. Therefore, applicants for development approvals¹ should carefully consider the adequacy of water availability at an early stage of planning developments in the City of Spokane Valley.

¹ "Development approvals" include subdivisions, short plats, binding site plans, manufactured home park site development plans, planned unit developments, zoning reclassifications, and conditional use permits that would permit an increased amount of wastewater to be generated on the site.
